RE: Initial Consultation

Dear Friend,

Thank you for your interest in becoming a patient at the office of Dr. Martin Mulders. We congratulate you on your decision to take better control of your health. The following are guidelines to best prepare for your office visit.

Pre-Appointment Preparation

- 1. Informational materials are enclosed for your completion prior to your visit. Please type or print clearly and return the questionnaire to our office for the doctor's review.
- 2. When you fax or email your completed Patient Questionnaire, you may include pertinent medical records from the last six months—i.e., physician's notes, lab tests, EKG, imaging reports. Please do not send films or discs.
- 3. When Dr. Mulders has reviewed the completed Patient Questionnaire, we will call you to schedule a visit. Please allow for at least 1 ½ hours in our office. A deposit of \$300 is required to hold the scheduled time for you. We ask you to provide credit card information for that deposit which will be applied to the initial visit consult fee.
- 4. If you cancel or reschedule your consult with less than 5 days' notice, you forfeit your deposit. If you cancel or reschedule with 5 or more days' notice, your deposit will either be refunded (for cancellations) or applied to your rescheduled initial visit fee.

Initial Visits

- 1. Please plan to arrive 15 minutes before your scheduled time. The initial visit with Dr. Mulders will include an in-depth medical interview and pertinent physical examination. Recommended diagnostic testing will be explained.
- 2. A follow-up appointment will be made, usually about 4 weeks later. During this visit, all findings will be discussed and a therapeutic program will be recommended. Please allow an hour for this follow-up visit.
- 3. Some patients have chemical sensitivities due to health difficulties or allergies. We ask that you refrain from wearing strong perfumes or oils when you visit the office.
- 4. You will receive copies of all your results and invoices at each visit. Please maintain them in your records. There will be a fee if you needs copies.

Fees/Insurance Coverage

Initial Visit \$650

First Follow-Up \$330 - \$400 Standard \$195 - \$310

- **1.** Costs for testing are in addition to the doctor's consulting fees above. Some lab fees may be required at your first visit. Because insurance plans vary widely, it is not possible for our office to indicate whether your plan will reimburse your expenses for fees, testing, nutrient and other therapies.
- 2. Dr. Mulders is not a Medicare or Medicaid participating provider. He has "opted-out" of Medicare meaning that you will not be reimbursed from Medicare for the services rendered by Dr. Mulders. If you are eligible for Medicare, your signature will be required on a private contract agreement. Many of the lab tests and other diagnostic tests ordered by Dr. Mulders may be covered if these are considered medically necessary by Medicare. For Medicaid beneficiaries, services or orders provided by Dr. Mulders will not be covered by Medicaid. The person is responsible for all costs.
- **3.** We are a "fee for service practice", and because of the complex and time-consuming nature of our diagnostic work and the innovative nature of some of our treatments, we are considered "out of network" providers. Therefore, we cannot be responsible for submitting your insurance claims. We will provide you with documentation of the visit including diagnostic and procedural codes on your paid invoice which you can submit to your insurance plan. Please note that Dr. Mulders will not complete disability evaluations nor fill out disability forms.
- **4.** We accept Master Card, Visa and personal checks.

We look forward to seeing you and helping you to regain your health.
